### Additional Important Observations

- On the surface, significant outside funding does not appear to result in significant increase in scoring
- The most costly Staunton District project recommended in the OIPI Staff recommendation was \$3.5 million.
- 7 of the 16 projects initially recommended for funding were projects that do not add or improve roadway capacity.
- Staunton District had 13 projects with SmartScale scores higher than the Hampton Roads Bridge Tunnel that were not considered for funding



### <u>Conclusion</u>

 While the original SmartScale legislation did not specifically reference issues such as SmartScale score vs Benefit Score, it is the opinion of staff that the program is not operating in the manner envisioned by its adopters.



### Where are the key issues?

- <u>Equity</u>
  - The limiting factor for consideration in Step 2 based on lowest scoring Step 1 projects leads to worthy projects not being considered and is a built in advantage to districts that already have larger District Grant allocations
  - Rule changes mid process that appear to benefit certain projects or areas to the detriment of others statewide are wrong.
- <u>Transparency</u>
  - There are many elements of scoring that localities cannot predict. In a quantitative process this should not be true.
- <u>Flexibility</u>
  - Localities should have the freedom to choose which pots of money they apply for

#### 3. WinFred CLRP Amendment Request for I-81 Projects – Terry Short, VDOT

Mr. Short updated the group on the I-81 meeting and discussed anticipated topic of priority setting. Widening project included in I-81 plan must be included in the CLRP in order for VDOT to move the project forward should it be funded. This is a proactive request to send it to the 20 day public comment period, pending no public comment, it will stand approved. Ms. McCann-Slaughter made the motion to approve the request, motion seconded by Mr. Wiley. Motion carried.

#### 4. System Planning Update – Terry Short, VDOT

North Winchester Area Plan is underway. Counts have been taken and now working with County staff to inform projections. Substantial growth is expected. They are working to confirm that the growth projections are realistic and defensible. Discussion ensued regarding Greystone warehousing development for inclusion and raised concerns regarding existing conditions with multiple stoplights and intersections. Asked about Red Bud realignment as a potential option to remove one of the stoplights. Mr. Short confirmed that eliminating one of the signals is suggested in a phase 1 plan, but it won't solve the problem on its own. Further improvements are required in order to have significant impacts. Discussion continued regarding small scale short-term

improvements and large-scale long-term improvements. Mr. Bishop suggested that there may be an opportunity to use Apple Valley leftover funds to do some signal upgrades in this area. Exit 317 to 321 – Ms. McCann-Slaughter requested advocacy for this section as well. Submit letter regarding potential cost savings by conglomerating projects in the area and taking advantage of planning that the MPO is performing. Motion made by Mr. Short and seconded by Ms. McCann-Slaughter approving the draft the letter.

Work progressing on Route 7 STARS – existing conditions report received.

Pleasant Valley Road STARS – recent presentation was made to Winchester City Council. Existing conditions counts complete. Amending study per input from Council. Received new framework document based on changes.

Mr. Madera<sup>o</sup>updated on Millwood and Mall Blvd redesign. Prime AE has been selected. Scoping meeting has been held. Planning level 30% design will be included in the project.

522 Relocation Study – Mr. Madera will meet with Mr. Sabo with the Winchester Airport to receive feedback. Scope and fee meeting will follow.

CLRP Update- Mr. Madera stated that the project is coming along and will have projects for review by TAC and Policy Board over the next few months.

**Glossary of Acronyms on Next Page** 

#### **Glossary of Acronyms**

**CAC-** Citizen Advisory Committee- Serves as an advisory committee to the MPO Policy Board to solicit public input and provide citizen perspective on MPO projects. Conduct public hearings and public input sessions on selected projects at the direction of the Policy Board.

**CLRP** – Constrained Long Range Plan – A fiscally-constrained list of projects drawn from the Vision Plan element of the LRTP. All CLRP projects must have an estimated cost and a revenue source identified.

**FHWA** - Federal Highway Administration - Within the US Department of Transportation, FHWA is responsible for highway issues, including federal laws and regulations related to metropolitan transportation planning.

**FTA** - Federal Transit Administration- With in the US Department of Transportation, FTA is responsible for public transit issues, including federal laws and regulations related to metropolitan transportation planning.

**FTA Section 5303 Funds** - This program supports transit planning expenses to support cooperative, continuous, and comprehensive planning for making transportation investment decisions in metropolitan planning areas.

**FTA Section 5310** - Transportation for Elderly Persons and Persons with Disabilities - The goal of the Section 5310 Program is to provide assistance in meeting the special transportation needs of elderly persons and persons with disabilities. The program is designed to supplement other FTA or assistance programs by funding transportation projects for elderly person and persons with disabilities in all areas – urbanized, small urban, and rural.

**LRTP-** Long Range Transportation Plan- Developed and approved by the MPO, the LRTP is a regional plan that includes all transportation projects and programs that the MPO realistically anticipates can be implemented over the next 25 years. LRTP's may include a VISION PLAN, which is a list of all projects (a "wish list"), but must also include a CLRP. In order to receive federal funding, transportation projects must be included in the LRTP and the TIP.

**MPO** - Metropolitan Planning Organization - Federal transportation laws and regulations require the establishment of an MPO in every urbanized area of the U.S. with a population over 50,000. MPOs are responsible for meeting the federal metropolitan planning regulations for transportation.

STP Funds - STP funds are Federal Funds disbursed through State DOT's for Surface Transportation projects.

**TAC-** Technical Advisory Committee- Serves in an advisory capacity to the Policy Board of the MPO. The TAC works with MPO staff to formulate the UPWP, the LRTP, and provides technical review and asistance on numerous MPO projects undertaken as called out in the UPWP.

**TIP** - Transportation Improvement Program - Approved by the MPO Policy Board, it is a list of projects and programs that will be implemented over the next six years. In order to receive federal funding, transportation projects must be included in the Constrained Long Range Plan and the TIP. Amendments are major changes to a project included in the CLRP, TIP or STIP that are not Administrative Modifications.

**UPWP** – Unified Planning Work Program- MPOs must adopt and implement an annual work program and budget known as the Unified Planning Work Program (UPWP). The UPWP identifies all activities to be undertaken by the MPO during the fiscal year which begins July 1<sup>st</sup> and ends the following June 30th.

**VDOT - Virginia Department of Transportation** – The Agency responsible for statewide transportation facility planning, construction, and maintenance. VDOT is separate from the Virginia Department of Rail and Public Transportation (VDRPT).

**VDRPT** - Virginia Department of Rail and Public Transportation – The Agency under the Virginia Secretary of Transportation (as is VDOT) provides technical and financial assistance to Virginia's public transit.
