#### **Glossary of Acronyms**

- **CAC-** Citizen Advisory Committee- Serves as an advisory committee to the MPO Policy Board to solicit public input and provide citizen perspective on MPO projects. Conduct public hearings and public input sessions on selected projects at the direction of the Policy Board.
- **CLRP** Constrained Long-Range Plan A fiscally-constrained list of projects drawn from the Vision Plan element of the LRTP. All CLRP projects must have an estimated cost and a revenue source identified.
- **FHWA** Federal Highway Administration Within the US Department of Transportation, FHWA is responsible for highway issues, including federal laws and regulations related to metropolitan transportation planning.
- **FTA** Federal Transit Administration- With in the US Department of Transportation, FTA is responsible for public transit issues, including federal laws and regulations related to metropolitan transportation planning.
- **FTA Section 5303 Funds** This program supports transit planning expenses to support cooperative, continuous, and comprehensive planning for making transportation investment decisions in metropolitan planning areas.
- **FTA Section 5310 -** Transportation for Elderly Persons and Persons with Disabilities The goal of the Section 5310 Program is to help in meeting the special transportation needs of elderly persons and persons with disabilities. The program is designed to supplement other FTA or assistance programs by funding transportation projects for elderly person and persons with disabilities in all areas urbanized, small urban, and rural.
- **LRTP** Long Range Transportation Plan- Also called the Metropolitan Transportation Plan (MTP). Developed and approved by the MPO, the LRTP is a regional plan that includes all transportation projects and programs that the MPO realistically anticipates can be implemented over the next 25 years. LRTP's may include a VISION PLAN, which is a list of all projects (a "wish list") but must also include a CLRP. In order to receive federal funding, transportation projects must be included in the LRTP and the TIP.
- **MPO** Metropolitan Planning Organization Federal transportation laws and regulations require the establishment of an MPO in every urbanized area of the U.S. with a population over 50,000. MPOs are responsible for meeting the federal metropolitan planning regulations for transportation.
- MTP Metropolitan Transportation Plan see LRTP.
- STP Funds STP funds are Federal Funds disbursed through State DOT's for Surface Transportation projects.
- **TAC-** Technical Advisory Committee- Serves in an advisory capacity to the Policy Board of the MPO. The TAC works with MPO staff to formulate the UPWP, the LRTP, and provides technical review and assistance on numerous MPO projects undertaken as called out in the UPWP.
- **TIP** Transportation Improvement Program Approved by the MPO Policy Board, it is a list of projects and programs that will be implemented over the next six years. In order to receive federal funding, transportation projects must be included in the Constrained Long-Range Plan and the TIP. Amendments are major changes to a project included in the CLRP, TIP or STIP that are not Administrative Modifications.
- **UPWP** Unified Planning Work Program- MPOs must adopt and implement an annual work program and budget known as the Unified Planning Work Program (UPWP). The UPWP identifies all activities to be undertaken by the MPO during the fiscal year which begins July 1<sup>st</sup> and ends the following June 30th.
- **VDOT Virginia Department of Transportation** The Agency responsible for statewide transportation facility planning, construction, and maintenance. VDOT is separate from the Virginia Department of Rail and Public Transportation (VDRPT).
- **VDRPT Virginia Department of Rail and Public Transportation** The Agency under the Virginia Secretary of Transportation (as is VDOT) provides technical and financial assistance to Virginia's public transit.

# DRPT Report to WinFred MPO Policy Board October 19, 2022

### **Chief of Public Transportation**

 DRPT has selected Zach Trogdon as the new Chief of Public Transportation. He is set to join DRPT on October 25 and comes from the Williamsburg Area Transit Authority (WATA) where he has served as Executive Director since 2017. Grant Sparks will resume his role as Director of Transit Planning once Zach has started as Chief.

### Virginia Statewide Rail Plan

- DRPT hosted a virtual public meeting on September 27, 2022 from 6-7PM for the Virginia Statewide Rail Plan. The public meeting included a draft plan for review through to the end of October.

# VDOT District Planning Report to WinFred MPO Policy Board October 2022

**SMART SCALE:** The SMART SCALE Round 5 application deadline was August 1, 2022. Within the VDOT Staunton District, 42 total applications were submitted with a total SMART SCALE funding request of \$336.4 million. Within the WinFred MPO region, there were 7 total applications submitted (3 within the City of Winchester and 4 within Frederick County) with a SMART SCALE funding request of \$77.2 million. The SMART SCALE applications are currently in VDOT District and Central Office Validation and Scoring. The scoring results and the draft recommended funding scenario are expected to be released in January 2023.

**STARS Study:** The VDOT Strategically Targeted Affordable Roadway Solutions (STARS) study program is returning this year. This study program focuses on safety and operational roadway and multi-modal needs and evaluates improvement alternatives that address the identified needs. The study deliverables for the STARS program include a funding application ready conceptual sketch and estimate. In coordination with the City of Winchester, Frederick County and the MPO, VDOT Staunton District Planning has submitted a STARS study application to VDOT Central Office for the section of US 50 from Keating Drive in the city to the entrance of the VDOT Area Headquarters in the county. The STARS study is anticipated to get underway by the end of the year.

**HSIP Local Systemic:** The application window for localities who maintain their own roadways to submit systemic safety improvements for funding consideration through the Highway Safety Improvement Program (HSIP) is currently open and closes November 1, 2022. For state maintained roadways, HSIP applications are submitted by the VDOT District. More information can be found here: <a href="VDOT HSIP Website">VDOT HSIP Website</a>

**OIPI GAP Technical Assistance Program:** The application window for the Office of Intermodal Planning and Investment's Growth and Accessibility Planning (GAP) technical assistance program is currently open and closes October 31, 2022. #### **Glossary of Acronyms**

- **CAC-** Citizen Advisory Committee- Serves as an advisory committee to the MPO Policy Board to solicit public input and provide citizen perspective on MPO projects. Conduct public hearings and public input sessions on selected projects at the direction of the Policy Board.
- **CLRP** Constrained Long-Range Plan A fiscally-constrained list of projects drawn from the Vision Plan element of the LRTP. All CLRP projects must have an estimated cost and a revenue source identified.
- **FHWA** Federal Highway Administration Within the US Department of Transportation, FHWA is responsible for highway issues, including federal laws and regulations related to metropolitan transportation planning.
- **FTA** Federal Transit Administration- With in the US Department of Transportation, FTA is responsible for public transit issues, including federal laws and regulations related to metropolitan transportation planning.
- FTA Section 5303 Funds This program supports transit planning expenses to support cooperative, continuous, and comprehensive planning for making transportation investment decisions in metropolitan planning areas.
- **FTA Section 5310** Transportation for Elderly Persons and Persons with Disabilities The goal of the Section 5310 Program is to help in meeting the special transportation needs of elderly persons and persons with disabilities. The program is designed to supplement other FTA or assistance programs by funding transportation projects for elderly person and persons with disabilities in all areas urbanized, small urban, and rural.
- **LRTP** Long Range Transportation Plan- Also called the Metropolitan Transportation Plan (MTP). Developed and approved by the MPO, the LRTP is a regional plan that includes all transportation projects and programs that the MPO realistically anticipates can be implemented over the next 25 years. LRTP's may include a VISION PLAN, which is a list of all projects (a "wish list") but must also include a CLRP. In order to receive federal funding, transportation projects must be included in the LRTP and the TIP.
- **MPO** Metropolitan Planning Organization Federal transportation laws and regulations require the establishment of an MPO in every urbanized area of the U.S. with a population over 50,000. MPOs are responsible for meeting the federal metropolitan planning regulations for transportation.
- MTP Metropolitan Transportation Plan see LRTP.
- STP Funds STP funds are Federal Funds disbursed through State DOT's for Surface Transportation projects.
- **TAC-** Technical Advisory Committee- Serves in an advisory capacity to the Policy Board of the MPO. The TAC works with MPO staff to formulate the UPWP, the LRTP, and provides technical review and assistance on numerous MPO projects undertaken as called out in the UPWP.
- TIP Transportation Improvement Program Approved by the MPO Policy Board, it is a list of projects and programs that will be implemented over the next six years. In order to receive federal funding, transportation projects must be included in the Constrained Long-Range Plan and the TIP. Amendments are major changes to a project included in the CLRP, TIP or STIP that are not Administrative Modifications.
- **UPWP** Unified Planning Work Program- MPOs must adopt and implement an annual work program and budget known as the Unified Planning Work Program (UPWP). The UPWP identifies all activities to be undertaken by the MPO during the fiscal year which begins July 1<sup>st</sup> and ends the following June 30th.
- **VDOT Virginia Department of Transportation** The Agency responsible for statewide transportation facility planning, construction, and maintenance. VDOT is separate from the Virginia Department of Rail and Public Transportation (VDRPT).
- **VDRPT** Virginia Department of Rail and Public Transportation The Agency under the Virginia Secretary of Transportation (as is VDOT) provides technical and financial assistance to Virginia's public transit.
